1. GENERAL RULES AND CONDITIONS:

It is most important that Competitors, Teachers, Parents & Guardians read all rules & conditions carefully.

1.1 This competition is held under the auspices of the Burdekin Junior Eisteddfod Inc. (herein referred to as eisteddfod or competition) and is open to Amateurs only. An amateur shall be defined as a person whose principal source of income is not derived from the exercise of his or her talents in the particular class or classes which he or she has entered. This condition does not apply to Conductors and Accompanists.

1.2 AGE LIMITS

- a. The age limit stated for all competitors in this Eisteddfod is 18 years and under on or before commencement date of the eisteddfod, age for Irish is as at 1st January of the current year. Proof of age may be required.
- b. In the case of a dispute, prizes will be withheld until such proof is forthcoming.
- c. Age groupings will be determined by the Eisteddfod after close of Entries. The Eisteddfod will make its best effort to have a minimum age division of 12 years and under and 18 years and under, however reserves the right to combine ages due to lack of entries.

1.3 Submission of members names

- a. Names of all members in Duos, Duets and Trios must be submitted on the official entry Form.
- b. In the case of Groups and Ensembles all members and their birth dates must be listed. Please highlight the youngest and the eldest on your entry form.
- c. If any competitor/s in Duets/Duos, Trios or Groups is prevented from performing due to withdrawal of one partner, a substitute can be used. Trios may be reduced to Duos if necessary. These changes will be accepted provided all other conditions are met. Name/s and Date of Birth of substitute/s must be handed to the Secretary/Marshal at least one hour before commencement of the Section.

1.4 Competitors are only allowed to compete once in a section.

1.5 Entries will not be accepted if they do not contain the following:

- a. A separate Entry Form for each child doing Solos. Except in the case of Bulk Teacher entries which are to be submitted on the teacher entry form.
- b. Fees as set out hereunder (Clause 1.7), relevant to the entries submitted. Cheque's and Money Order's are to be made payable to Burdekin Junior Eisteddfod Inc. Please do not send cash through the post.
- c. Full Name and Address, Date of Birth and Age as at commencement date of the eisteddfod must be included on Entry Form. Age for Irish is as at 1st January of the current year.
- d. A stamped, self-addressed envelope for return of Competitor's Ticket/s should be included. Please use the same address on envelope as submitted on Entry form.
- e. **Copies of Music and Speech and Drama Scripts on nothing other than A4 Paper, Name of composer/arranger or author/poet to be nominated on entry form if applicable.**
- f. Appropriate Copyright Declarations if required. (See clause 1.33)

1.6 Closing Dates

- c. Entries may be left at the Eisteddfod Office located at 142b Young St AYR, QLD 4807, or Posted to PO Box 807, AYR 4807.
- d. Speech/Drama scripts & Music to be submitted by **30th March 2012**.
- e. Art and Literary pieces to be submitted by **20th April 2012**.

- 1.8 All sections in this Eisteddfod are “Own Choice” unless otherwise stated in the appropriate section. Submission of this work into the correct section/s is the responsibility of the Competitor or Teacher.
- 1.9 The order of appearance should be strictly observed by Competitors unless otherwise directed by the Chairman of the Session or the Eisteddfod.
- 1.10 Competitors must not have had any tuition whatever from the Adjudicator/Adjudicator’s school during the 3 months prior to the commencement of the Eisteddfod. In the case Irish this is increased to 2 years.
- 1.11 The Adjudicator’s decision will be final, and he/she also has the power to share or withhold placing on merit. No prompting will be permitted except by the Adjudicator. At the discretion of the Adjudicator Competitors may be given a second opportunity to complete their item.
- 1.12 Material must be selected with a view to the age of the competitors and with a realisation that there are many children in the audience. If the Adjudicator should decide that;
- a. choice of work; or
 - b. presentation of same;
- is unsuitable or unacceptable for a Juvenile Eisteddfod it will be at their discretion to deduct marks, or refuse to mark at all.
- 1.13 When necessary, a Competitor shall cease the performance on the sound of the Adjudicator’s bell. This is not a reflection on quality, but means the Adjudicator has seen or heard sufficient of that item to make adjudication.
- 1.14 A written adjudication on all performances (except Highland and Irish Dancing), including non-place-getters, will be available from the “**official table**” at the completion of the Section. No adjudication slips will be held by the Committee after the Close of the Eisteddfod.
- 1.15 Any approach before or during competition, to an Adjudicator by an Entrant, Parent, Teacher or Friend of an Entrant during the Eisteddfod is discouraged. This rule does not apply to the Eisteddfod committee.
- 1.16 If through unforeseen circumstances the Adjudicator is unable to perform his/her duties, the Eisteddfod reserves the right to appoint a substitute.
- 1.17 The Eisteddfod reserves the right to: -
- a. Amend the Program should it be considered necessary.
 - b. Cancel section where there are insufficient entries i.e. less than three competitors.
 - c. Combine age groups wherever appropriate. (In keeping with clause 2)
 - d. Re-allocate trophies.
- 1.18 Time limits as set out in each section shall not be exceeded. **To do so may result in loss of marks.**
- 1.19 **Back Stage Rules**
- a. At no time during the Eisteddfod will unauthorized persons be permitted backstage, in the wings or in the dressing rooms.
 - b. Dressing rooms will be closed to all except when necessary for costume changes. Persons dressing children may remain in the dressing rooms until item in progress is completed.
 - c. The only time/occasion a teacher or parent is allowed in the wings will be for all groups and 6years and under sections.
 - d. Any teacher or parent found coaching from the wings will be removed.
- 1.20 No teacher/parent will be allowed on stage during rendition of any item, unless as Accompanist or Conductor.

1.21 Check In/Withdrawals

- a. Competitors must check in with the Marshall. They may leave, but must return when the section is called.
- b. Competitors are encouraged to be at the venue in plenty of time to be marshaled for their section/s.
- c. **Competitors will be deemed as "Withdrawals" if they are not present when called for their section/s.**

1.22 Once the Competitors are seated for competition in their section/s they must remain in the auditorium until the section is completed, unless directed otherwise by the Marshals. All competitors in the music section will enter stage from auditorium except for Modern Pop Solo.

1.23 The Eisteddfod will not make the stage available for rehearsals prior to, or through the duration of the Eisteddfod. Should a competitor wish to do this, it will be via private booking with the Burdekin Theatre Management, as long as it does not interfere with the normal running of the Eisteddfod. The Eisteddfod will not be responsible for any costs incurred.

1.24 The Eisteddfod will not be responsible for the engraving of perpetual trophies. An account will be sent to the previous recipient if the Eisteddfod has engraving completed on their behalf.

1.25 Competitors compete at their own risk.

1.26 No alteration to stage lighting will occur.

1.27 No items will be permitted which entail the use of sand, hay, water, smoke, fog, dry ice, cream, food, drink, powder, electrical appliances, live animals or the of naked flames on stage for effect purpose.

1.28 The use of the curtain will be limited to Small Plays and Group Mime ONLY.

1.29 No flashlights, cameras of any kind, recording devices of any kind, or electronic games are to be taken into the venue. Mobile phones are to be switched off before entering the venue.

1.30 PROTESTS

- a. Protests are to be lodged in writing at the official table, and be accompanied by a fee of \$25.00.
- b. The protest must be lodged before the completion of the following session.
- c. The \$25.00 fee will be forfeited if the protest is not upheld.
- d. Disputed matters will be investigated and discussed by the Protest Committee; **this committee's decision is final.**

1.31 A high standard of decorum is expected from all participants and spectators. Unpleasant or offensive behavior may result in those responsible being asked to leave and offending entrants may be disqualified. These rules also apply to misuse of the Venue and Eisteddfods facilities.

1.32 The committee reserves the right to take any/all action to facilitate the satisfactory conduct of the Eisteddfod.

1.33 The Eisteddfod is conducted under the relevant Queensland Government Workplace Health and Safety Regulations and expects all competitors, volunteers, patrons, teachers and visitors to respect these guidelines and will not be held liable for any such person who does not.

1.34 COPYRIGHT REGULATIONS

a. PRINT MUSIC

The following is an extract from "*Music copyright for Eisteddfods*" First Edition 2006:

*"To put it quite simply - competitors are responsible for clearing copyright where necessary or performing from original published editions of music. This is NOT the responsibility of the eisteddfod organisation, but it remains the responsibility of the **individual competitor.**"*

With this in mind all competitors must ensure that they follow all appropriate copyright laws, for information on copyright please visit www.apra.com.au or contact APRA directly.

- i. All competitors performing from sheet music must submit a FORM 1 – Performers Declaration Form for Eisteddfods and Music Competitions. This form only needs to be submitted once per competitor, i.e. one form will cover the competitor for all sections they have entered including vocal, piano, instrumental, solos, duets, ensembles, etc.
- ii. Competitors must submit a FORM 2 – Adjudication Copy for Use in Eisteddfods and Music Competitions. This form must be submitted for each copy of sheet music submitted, i.e. if a competitor enters in a Classical Piano Solo, Novelty Piano Solo and a Vocal Solo there would be 3 forms submitted 1 attached to each copy.

b. SPEECH AND DRAMA

The following is an extract from *“Music copyright for Eisteddfods” First Edition 2006*:

“If a competitor makes a photocopy of a work or edition that is still protected by copyright, they will need to check to see if their eisteddfod organisation has a CAL Association’s Licence. If it does, then a competitor may make a copy of a literary, dramatic or artistic work if it is part of CAL’s repertoire. To find out if it is covered, you would need to consult CAL’s Directory of Authors and Publishers

If the work or edition is not covered by the licence, or if the eisteddfod organisation does not have a CAL Association’s Licence, the Competitor will need to seek direct permission from the copyright owner of the material. In most cases this will be the publisher of the work.”

The Burdekin Junior Eisteddfod holds a current CAL Association License. Please visit www.copyright.com.au for further information on CAL Licensing.

c. BALLET AND DANCE

The following is an extract from *“Music copyright for Eisteddfods” First Edition 2006*:

“Dance schools may have a joint AMCOS/ARIA licence which permits the making of audio recordings or the copying of existing recordings for ease of cuing purposes, for example, to be used as backing tracks for a performance. Dance schools that have made a recording under the AMCOS/ARIA dance school licence may need to quote their licence number to the eisteddfod to prove that their recordings have been made legitimately under this licence.”

To cover The Burdekin Junior Eisteddfods copyright obligation it is a requirement as stated in clause 5.6b that all recordings used for the performance of Ballet and Dance, be marked with the appropriate AMCOS/ARIA copyright licence number.

2. HIGHLAND – Adjudicator: Kathy Ferguson

These rules are to be read in conjunction with the General Rules and Conditions, it is most important that Competitors, Teachers, Parents & Guardians read all rules & conditions carefully.

- 2.1 This competition is registered with the FNQRCHD (Req. No. FNQ) and will be conducted under the rules and conditions as set down by the SOBHD as adopted by ABHDI and the Eisteddfod.
- 2.2 All competitors must be **registered dancers** and registration number must be shown on Entry Form. Registration card must be brought to the competition to be presented in order to receive a competition number and prizes.
- 2.3 Age of the Competitor will be taken as at the date of the Competition.
- 2.4 All competitors compete at their own risk.
- 2.5 All steps from the official Text Book of the Scottish Official Board of Highland Dancing. Swords will be supplied by the Eisteddfod and used by all competitors.
- 2.6 Competitors must use the official music provided.
- 2.7 Age groups will be decided on receipt of entries. (In line with Clause 1.2)
- 2.8 Entry money will not be refunded unless “NO DANCE” is declared.
- 2.9 Entries will not be accepted unless accompanied by the correct entry fee.
- 2.10 A stamped, self-addressed envelope for return of Competitor’s Ticket/s should be included.
- 2.11 Cheque’s and Money Order’s are to be made payable to Burdekin Junior Eisteddfod Inc. Please do not send cash through the post.
- 2.12 **Entry Fees are as set out in the General Rules and Conditions in the front of the Program.**
- 2.13 The Adjudicator’s decision is to be final except in cases of dispute regarding AGE or INCORRECT ENTRY, when the decision of the Protest Committee shall be final. (See Clause 1.29) Where the age of a competitor is the subject of protest, a birth certificate may be required.
- 2.14 **PROTESTS**
Any complaint made by an Individual against the Organisation or Adjudication of any event, must be in writing giving the Complainant’s full name and address, and shall be lodged with the Organiser if possible on the day of event, certainly no later than 48 hours of the event. Such complaint is to be accompanied by a fee of \$5.00 which is refundable if protest is upheld. (SOBHD “IX” P45).
- 2.15 Competitors forfeit their right to dance if not in the marshalling area once section has commenced.
- 2.16 Adjudicators on the SOBHD Panel who conduct teaching or coaching classes or seminars for dancers (excepting only Championship step or medal test seminars for judges and/or full members of Examining Bodies) may not adjudicate any competitor who has attended any of these classes for a period of three months after the last class or workshop that competitor attended.
- 2.17 Eligibility of “Pre-Premier” Sections applies as at date of competition, and shall be in accordance with the SOBHD Registration Scheme.
- 2.18 Competitors must advise the Entries Secretary as soon as possible of any change of level that may occur between the closing date of entries and the date of competition.
- 2.19 Due to interference to competition, no practicing will be permitted around or behind the stage area.

2.20 If a competitor fails to fill-in in any Reel, (unless for a medical reason), the Organiser has the right to enforce Rule 1F, Page 28, D-Judges, SOBHD Rules and Regulations, which reads “Provided due prominence is given to the fact in the Program or in a brochure by the Organiser, then during the course of competition the component of the competitors may come under the jurisdiction of the Judges, not only whilst dancing but also when entering or leaving the platform and whilst waiting for the dance to start. Any unseemly behavior on the part of a competitor or any misdemeanor likely to upset the decorum of the proceedings may be penalized by the Judges and could lead to disqualification, but a full report on any such misconduct on the part of a competitor must be submitted by the Judges to the Organiser.”

2.21 **ALL place getters must be dressed in FULL COSTUME, for stage presentation.**

3. HIGHLAND CHOREOGRAPHY GROUPS – Adjudicator: Kathy Ferguson

These rules are to be read in conjunction with the General & Highland Rules and Conditions and well as the, it is most important that Competitors, Teachers, Parents & Guardians read all rules & conditions carefully.

- 3.1 The group choreography competition is open to registered dancers; the age grouping will be set by the eisteddfod.
- 3.2 Content should consist primarily of movements from Highland, National, Hornpipe and Jig books
- 3.3 A maximum of 5mins time limit should be set to include entrance of competitors and setting up and removal of props
- 3.4 Teams may use props during their performance, either static or non static, but live animals are not permitted.
- 3.5 A minimum of three dancers to perform in a group.
- 3.6 Music may be live or prerecorded and may include vocal or percussion selections, but in all cases must be predominantly Scottish or Celtic in style.
- 3.7 Costumes must follow the theme and content.
- 3.8 Teams should consist of:
 - a. One school only
 - b. More than one school, and which case, the teacher/choreographer must abide by the three month teaching/judging rule.

3.10 Teachers only to submit Choreography Group Entries. Please list names of dancers. (See Clause 1.3)

4. IRISH – Adjudicator: Kathy Ferguson

These rules are to be read in conjunction with the General Rules and Conditions, it is most important that Competitors, Teachers, Parents & Guardians read all rules & conditions carefully.

- 4.1 This competition is registered with the Irish Dancing Commission Dublin, and AIDA North Queensland Sub Committee.
- 4.2 Competitors must be pupils of registered AIDA Teachers.
- 4.3 No entry will be accepted unless accompanied by the correct fee and submitted on the official entry form which has been signed by the teacher. Proof of age must also be ascertained. Age for Irish is as at 1st January of the current year.
- 4.4 There must be a minimum of three (3) competitors to make up a section. If a competitor is placed in a higher age group than entered e.g. 6 Years up to 8 Years the teacher has the right to scratch the competitor and the entry fee on this occasion will be refunded.
- 4.5 Eisteddfod reserves the right to amend the order of Dances and Age Groups at any time.
- 4.6 Competitors must be ready to take their positions on the stage at the appointed times unless under extreme circumstances when the Eisteddfod decision will finalise the matter.
- 4.7 In the case of a tie there will be no dance off. Competitors in the next position will move back a place.
- 4.8 Competitors will be required to dance to the music as supplied by the Eisteddfod, teachers are required to supply own music for Own Choice Set Dances and Figure Dancing.
- 4.9 If there is any problem with music, the dancer will be permitted to re-dance at the Adjudicator's discretion.
- 4.10 No recorder other than the one in use for the dancer on stage may be played whilst a dancer is on stage.
- 4.11 If a shoe comes off or falls apart during a performance, the dancer must stop dancing at once and remove the shoe from the stage. They will then be allowed to re-dance in another pair of shoes. If the competitor keeps dancing they will not be allowed to re-dance.
- 4.12 If two (2) dancers bump hard during a performance they may re-dance at the Adjudicator's discretion.
- 4.13 **PROTESTS**

Any complaint made by an Individual against the Organisation or Adjudication of any event, must be in writing giving the Complainant's full name and address, and shall be lodged with the Organiser if possible on the day of event, certainly no later than 48 hours of the event. Such complaint is to be accompanied by a fee of \$25.00 which is refundable if protest is upheld.
- 4.14 Competitors enter at their own risk regarding injury.
- 4.15 To receive prizes or awards, competitors must be in full dancing costume including shoes. Any competitor not in costume will not be allowed to stand on the stage with the other winners.
- 4.16 The Eisteddfod will not enter into any correspondence with parents or non-parents concerning the organisation and procedure of competition unless these matters are put in writing and presented at an Eisteddfod meeting.
- 4.17 No flashlights, cameras of any kind, recording devices of any kind, or electronic games are to be taken into the venue. Mobile phones are to be switched off before entering the venue.
- 4.18 Failure to comply with any of the foregoing rules shall involve disqualification and the withholding of prizes. The decision of the AIDA Inc in any question of dispute shall be final.
- 4.19 NO PROMPTING by any person will be allowed except in the case of an INEXPERIENCED BEGINNER.

4.20 The length and speed of solo dancers are as set down by AIDA Inc.

b. Props are limited to those that can be placed on stage by the competitor within a time limit of 1 minute.
c. DURING THE ITEM, PROPS ARE TO BE MANIPULATED BY THE COMPETITOR ONLY. This condition may be relaxed in the case of groups subject to the Eisteddfods approval.
d. All due care, but no responsibility, will be taken by the Eisteddfod for props on or off the stage.

5.5 Synopses must be handed to the Marshall upon being called for the section.

5.6 CONDITIONS FOR USE OF CASSETTES, CDS & MINI DISCS:

- a. **There must be only a single track per Cassette, CD or Mini Disc. THIS RULE WILL BE STRICTLY ADHERED TO. CDRW will NOT operate on the equipment**
b. All recordings must be marked with **Competitor's Name, Number, Section and AMCOS/ARIA License No.**
c. Competitors are responsible for the production of their own recordings. The Eisteddfod while providing adequate playback equipment, accepts no responsibility for quality of the reproduction.
d. Competitors will hand their recording to the marshal upon being called for their section.

5.7 PROTESTS

5.8 No practicing will be permitted around or behind the stage area.

5.9 AGE GROUPINGS

- a. Groups will be placed in sections in the following age levels: 9 years and under; 12 years and under; 13 years and over.
b. Whilst the eisteddfod will make every endeavor to follow clause 5.9.a, this clause shall not take precedence over clause 1.2.c.

5.10 If a competitor chooses to compete as a Tiny Tot, they may not compete in any other age group solos.

- 5.11 To enter in the Tap, Classical and Modern Championships' Sections, a competitor must be **13 Years or over** and also must compete in each of the equivalent Solo Sections in his/her relevant age grouping.
